- (b) The amount quote by the bidder should be inclusive of all charges such as labour, Uniform, Badges, transportation and all kinds of statutory levies and in accordance with the provision of minimum wages Act-1948.
- (c) The tender forms are clearly filled in ink legibly.
- (d) Every page of the tender document should be signed by the tenderer duly stamped which shall mean the acceptance of the terms and conditions of providing watch and ward services.
- (e) No enquiry verbal or written shall be entertained in respect of acceptance/rejection of tender.
- (f) Tenderer must agree to provide continuous security services on the same terms and condition after the expiry of the contract for the interim period till the new security contract commences.
- (g) Nagar Ayukt, Nagar Nigam, Allahabad reserves the right to reject any or all tender documents without assigning any reason(s).

16. Physical and personallty standard of the security guard will be as follow:

- (a) Should wear clean & neat uniform.
- (b) Physically fit(not impaired sight & sound, physical Fitness Certificate to be produces in case of each guard, if asked for).
- (c) Height not less than 5'4".
- (d) Non smoker.
- (e) Non alcoholic.
- (f) Unarmed guards should be equipped with lathi & whistle.
- (g) The contractor shall deploy only those personnel whose antecedents have been verified by the police authorities/district sainik board/record offices of the defense service.

17. Earnest Money Deposit (EMD) is to be given with the tender document. Tenders without EMD will be rejected. SCHEDULE OF SERVICE

18. Scope of work (Services to be provided)

- (a) To ensure Security and safety of premises, building, amenity, vehicles, store, fencing, electrical and water fittings, furniture, arboricultural assets, etc.
- (b) To prevent encroachment on government land, institutional amenity, building etc.
- (c) To ensure clearance of stray dogs, animals that destroy arboricultural assets etc. of the site (s) of deployment.
- (d) To ensure prevention of trespassing of unauthorized person into site (s) of under security cover. If such incidents, take place the culprits to be apprehended and arrangements to be made to hand them over to the civil police.
- (e) Security gaurds will perform the round the clock in shift manner. A single duty shift will have normal duration of 8 hours. In case of any compelling reason, if the duty shift is to be extended, the same shall not be resorted to by the contractor without the prior consent of the authorized officer of Nagar Nigam Allahabad.

19. Duty hours:

- (a) To shift 06.00 to 14.00
- (b) 2nd shift 14.00 to 22.00
- (c) 3rd shift 22.00 to 06.00

(Duty hours may however be changed by the authorized officer of Nagar Nigam Allahabad).
